With respect to Closed Session Agenda Item Nos. 17.A.1., 17.A.2. and 17.B., there was no consideration of those matters.

With respect to Closed Session Agenda Item 17.C., there was reportable action in the form of unanimous Board approval (6-0) of purchase and sale and escrow instructions with Millerton Investments, LLC a California Limited Liability Company/Grantor Real Estate Investments, LLC a California Limited Liability Company concerning terms of purchase of real property in Fresno County as a future District Station site on two conditions: (1) receipt upon Exhibit B, description of the property; and, (2) receipt of Exhibit C, an agreed upon description of the landscaped area of the involved property.

Additionally, your Board unanimously (6-0) indicated that either Board President, Matt Furrer, or District Chief, Dustin Hail is authorized to execute the Agreement approved by the Board. The Closed Session concluded at 7:29 p.m. with a unanimous vote (6-0) of the Board to reconvene in Open Session with the indication that a written Report Upon Return from Closed Session would be prepared consistent with the provisions of Government Code section 54957.1 for the matters agendized for Closed Session consideration.
