BOARD OF DIRECTOR'S BRIEFING PAPER

ISSUE:

Staff is recommending the District submit a CDBG application to purchase a new Water Tender to be stationed at Station 94. The CDBG application requires a Board resolution to authorize staff to execute and submit the application.

BACKGROUND:

The District has successfully submitted and completed several CDBG projects to refurbish water tenders over the last several years. The last project was the Water Tender 96 refurbish during the 2025-2026 CDBG.

DISCUSSION:

Staff anticipates that the purchase of Water Tender 94 would cost approximately \$622,000 to complete. The District would be seeking \$300,000 from the CDBG and would need to fund the remaining \$322,000 from the District budget.

ALTERNATIVES:

Not apply for the 2026-2027 CDBG and fund the entire project cost.
